  - a) Top of Page: Company Name, DBA Name, Address and Phone number
  - b) Date
  - c) Company Name
  - d) Amount on Deposit at the WV State Treasurer's Office
  - e) Signature and Title
3. Have the form notarized.
4. Mail or hand deliver the **original** to:
