CONTRACT ELEMENTS FORM AND CONTRACT AFFIDAVIT

Lottery Emergency Rule §179-5-49 requires an operator submitting a contract with a licensed video lottery retailer to complete and attach a completed Contract Elements form prescribed and furnished by the West Virginia Lottery.
