



**AFFIDAVIT  
FRATERNAL'S TRANSFER OF PERMITS  
HELD THROUGH CERTIFICATE OF RESERVATION TO OPERATOR**

**Now comes** \_\_\_\_\_, lawful representative of \_\_\_\_\_, a business possessing a video lottery retailer licensed under the Limited Video Lottery Act, who after first being duly sworn, affirms that the following is true:

**That** W.Va. Code §§ 29-22B-1104 and 1105 of the Limited Video Lottery Act allowed a limited video lottery retailer license holder who was licensed by the Alcohol Beverage Control Administrative (ABCA) on or before January 1, 2001 as a private club licensee or a Class A beer licensee and who applied for a limited video lottery retailer license on or before August 1, 2001, to reserve up to two video lottery terminals without resorting to the bidding procedure as found in W.Va. Code § 29-22B-1107.

**That** this licensed retailer was issued a Certificate of Reservation by the West Virginia State Lottery Commission for \_\_\_\_\_ video lottery terminals.

**That** W.Va. Code § 29-22B-1105 of the Limited Video Lottery Act allows that by submitting \$1,000.00 per allotted permit to the West Virginia State Lottery Commission a licensed fraternal holder may renew the right to reserve up to seven video lottery terminals for the ten-year permit period that begins July 1, 2021 and ends June 30, 2031, without resorting to the bidding procedure as found in W.Va. Code § 29-22B-1107.

**That** this licensed retailer renewed a Certificate of Reservation by the West Virginia State Lottery Commission for \_\_\_\_\_ video lottery terminals for the ten-year permit period that begins July 1, 2021 and ends June 30, 2031.

**That** West Virginia Code of State Rules § 179-5-16.9.a allows a licensed retailer with a certificate of reservation may contract with an operator for video lottery terminals and give the certificate of reservation to the operator.

**And that** this licensed retailer does now wish to transfer its Certificate of Reservation for \_\_\_\_\_ video lottery terminals to \_\_\_\_\_, a licensed limited video lottery operator, so that the West Virginia State Lottery Commission may issue a permit for \_\_\_\_\_ video lottery terminals to the above listed operator for the ten-year permit period that begins July 1, 2021 and ends June 30, 2031. If the licensed retailer loses its limited video lottery retailer license, the operator will retain its permit and video lottery terminals obtained by assignment of certificate until the Commission's next bid opening for permits.
