



7-11-21® LIVE! OFFICIAL CONTEST DETAILS

The 7-11-21® LIVE! promotion (the “Contest”) is an event produced by Scientific Games International, Inc. (“SGI”) in connection with participating state lotteries (“Lotteries” or “Lottery”). The Contest features a live broadcast (“Live Event”) streamed through each participating Lottery’s Facebook page. During the Live Event, the value of the Cash Prizes to be awarded will be determined in the Cash Prize Event. Winners are randomly selected for each participating Lottery jurisdiction after the conclusion of the Live Event from a pool of all eligible entries in that jurisdiction. The total number of Prizewinners depends upon Lottery participation levels. Prizewinners will each receive a Cash Prize, the value of which is determined during the Live Event. There are three potential Cash Prize values: \$77, \$777 and \$7,777. By participating in the Contest, each Prizewinner agrees all decisions regarding the Contest and Live Event are within the sole and exclusive discretion of SGI and are final and binding on all Prizewinners.

To participate in the Contest and qualify to be selected as a Prizewinner, participants must:

1. Tune in to the Live Event broadcast via their Lottery’s Facebook page;
2. Comment on the Live Event in the chat window with their lucky number at any point during the live broadcast; and
3. Meet all participating Lottery age and residency requirements.*

The Live Event will begin at 7:11:00 p.m. ET on July 11, 2021 and will last for a duration of approximately twenty-one (21) minutes. The Live Event consists of one (1) Cash Prize Event to determine the value of the Cash Prizes. The value of the Cash Prizes is selected during the Cash Prize Event in two (2) stages:

Stage One:

During the first stage of the Cash Prize value selection process the host draws four (4) envelopes from a mixing cage containing fifty (50) sealed envelopes. Each envelope contains one of three (3) possible Cash Prize values. The Cash Prize values and number of appearances each value will make in the set of fifty (50) sealed envelopes is as follows:

Prize Value	# APPEARANCES (out of 50)
\$77	35
\$777	10
\$7,777	5

The host then attaches one (1) envelope to each of the four (4) games on an oversized instant ticket.

Stage Two:

In this stage participants are presented with an interactive poll in which they are asked to vote for one (1) of the four (4) games/envelopes for the host to select as the final Cash Prize value. A countdown graphic is also shown, letting participants know the amount of time they have remaining to vote.

Upon conclusion of the polling period the results are displayed onscreen. The host then removes the one (1) envelope that received the most votes from the oversized instant ticket and opens it to reveal the value of the Cash Prizes.

In the unlikely event of a tied vote, the host will empty the mixing cage from Stage 1 and place the envelopes that received the most votes in Stage 2 into the mixing cage. After the mixing cage has been spun, the host will then select one (1) of the sealed envelopes randomly from the mixing cage and open it to reveal the value of the Cash Prizes.

Upon conclusion of the live broadcast, SGI shall use a contest management tool to export the comments from the Lottery’s Facebook Live chat window. SGI will then use the contest management tool to limit comments to one (1) comment per user. Prizewinners and alternates are then randomly selected from the Lottery’s exported comment file using the contest management tool.

Multiple Lotteries will participate in the Contest. Each participating Lottery receives their own selection from a pool of their own players.

After the selection is conducted and verified, eligible winners will be announced and tagged in a Facebook post on each participating Lotteries page. Winners must private message the Lottery on Facebook from the winning account in order to confirm their standing as a selected winner. Winners must follow the instructions provided and submit a copy of an acceptable form of identification, as required by the Lottery, as well as a valid email address and phone number. Individuals who fail to provide a valid email address and phone number will not be eligible to win.

If selected entrants do not respond to the notification within the time period specified by the Lottery, they will forfeit the prize. All selection entries are subject to verification by the Lottery or its designee and may be disqualified if eligibility requirements are not met.

If an entrant responds to the Lottery’s notification within the specified deadline but fails to provide a valid email address, phone number and acceptable form of identification to the Lottery, they may be disqualified and the prize will be awarded to an alternate. Only one (1) prize may be won by a person in the Live Streaming Event Selection.

Additional Rules and Procedures:

The payment of Cash Prizes is the sole responsibility of SGI. All Cash Prizes are not considered won and are not payable unless and until the independent auditor or third-party underwriter certify that the Live Event and Cash Prize Event have been conducted appropriately and in accordance with the official promotional Live Event Contest and Security Procedures (the “**Procedures**”) and that a Prizewinner has validly won the Cash Prize pursuant to the Procedures and is entitled to receive such Cash Prize. The Lottery shall have no liability for any Cash Prize amounts awarded as a result of the Contest.

All Cash Prizes won by the Prizewinners will be subject to the Lottery’s debt setoff procedures.

Purchase of an Instant Game ticket does not constitute an entry into the Contest.

All Cash Prizes awarded as a result of the Contest are underwritten by either SGI, third parties, or both.

Employees of the Lottery, SGI or other companies associated with the Contest, as well as members of their immediate families (spouses, parents, siblings and children) and household members of each such employee, are not eligible to participate in the Contest.

All decisions regarding technical difficulties, mechanical failures, or human errors, including but not limited to the premature reveal of any game material or elements, the malfunction of any piece of stage equipment or electronics or the failure of any audio equipment, in connection with the Contest will be determined by SGI in its sole discretion and shall be final and binding on all Prizewinners.

SGI reserves the right to change, add to, delete from, modify or amend these Contest details at any time at its sole discretion, subject to the approval of the participating state Lottery.

Odds of being selected as a Prizewinner vary by participating state Lottery depending upon the number of eligible entries received and the number of Cash Prizes available.

FAILURE TO COMPLY WITH ANY OF THE OFFICIAL PROMOTION AND/OR LIVE EVENT CONTEST DETAILS, PROMOTION AND/OR LIVE EVENT PROCEDURES, INDIVIDUAL EVENT GUIDELINES, ANY OTHER GUIDELINES, OR CODES OF CONDUCT SET FORTH BY SGI, MAY RESULT IN A PARTICIPANT’S DISQUALIFICATION AT SGI’S SOLE AND ABSOLUTE DISCRETION AND/OR THE REVOCATION OF ANY PRIZE WON AS A RESULT OF THE LIVE EVENT.
